ORDER

An application was made on the [REDACTED] 2014 by counsel for [REDACTED], the plaintiff, to the Judge who read the writ and the affidavits listed in Schedule 1 and accepted the undertakings in Schedule 2 at the end of this Order. After hearing the application the Judge made the following Order.

IT IS ORDERED that:

1. *Restriction on disposal of assets*

- (1) The defendant must not —
 - (a) remove from Hong Kong any of his assets which are within Hong Kong, whether in his own name or not, and whether solely or jointly owned, up to the value of US\$ [REDACTED] (approximately HK\$ [REDACTED]), or
 - (b) in any way dispose of or deal with or diminish the value of any of his assets, whether within or outside Hong Kong, whether in his own name or not, and whether solely or jointly owned up to the same value.

- (2) If the total unencumbered value of the defendant's assets in Hong Kong exceeds US\$ [REDACTED] (approximately HK\$ [REDACTED]) the defendant may remove any of those assets from Hong Kong or may dispose of or deal with them so long as the total unencumbered value of his assets still in Hong Kong remains above US\$ [REDACTED] (approximately HK\$ [REDACTED]).

If the total unencumbered value of The defendant's assets in Hong Kong does not exceed US\$ [REDACTED] (approximately HK\$ [REDACTED]), the defendant must not remove any of those assets from Hong Kong and must not dispose of or deal with any of them, but if he has other assets outside Hong Kong the defendant may dispose of or deal with those assets so long as the total unencumbered value of all his assets, whether in or outside Hong Kong, remains above US\$ [REDACTED] (approximately HK\$ [REDACTED]).
